COYOTE HUNT FEB. 26, 27, 28, 2016

Coyote Hunt Rules and Regulations.

1. No registrations will be taken during the hunt. The hunt will officially begin at 12:01 AM., Friday, February 26, 2016 and will end at 4:00 PM. on Sunday, February 28, 2016.
  2. Registration Fee will be \$20:00, of which 75% will go toward cash prizes to successful hunters. If you wish to register for the largest female coyote contest, it will cost an extra \$5.00. All money collected for female registration will be paid back as prize money.
  3. Each participant must be registered for this hunt. When hunting in groups, each member of the group must be registered, or the entire group will be disqualified.
  4. Coyotes must be killed during the days and times of the scheduled hunt.
  6. Participants must possess a valid hunting license or fur-taker license. Participant's said license will be checked when bringing in a coyote to be weighed.
  7. During the scheduled Coyote Hunt, coyotes may be hunted in any county in Pennsylvania.
  8. Calls and dogs may be used during the hunt, HOWEVER EACH HUNTER WILL BE ALLOWED TO REGISTER ONLY THREE COYOTES. The first three tagged coyotes will be the ones to be counted. EACH HUNTER MUST REGISTER HIS/HER COYOTE(S) KILLED IN PERSON.
  9. Buck Hill Firearms LLC reserves the right to have an autopsy performed on any animal presented at the hunt if it is believed the animal was poisoned, trapped or taken illegally. A veterinarian will be available to enforce this regulation. ALL ANIMALS WILL BE TAGGED THRU THE BACK LEG.
  10. Buck Hill Firearms LLC reserves the right to polygraph any registered hunter. HUNTERS UNDERSTAND AND AGREE THAT BY REGISTERING AND PARTICIPATING IN THE HUNT, THEY AGREE TO UNDERGO POLYGRAPH TESTING IF REQUESTED BY BUCK HILL FIREARMS LLC. POLYGRAPH QUESTIONS WILL BE LIMITED TO THOSE NECESSARY TO ASSURE THE ACCURACY OF THE RESULTS AND THE REGISTRANT'S ENTITLEMENT TO PRIZE MONEY. REFUSAL TO SUBMIT TO AND FULLY COOPERATE IN THE ADMINISTRATION OF A POLYGRAPH TEST SHALL RESULT IN THE AUTOMATIC DISQUALIFICATION OF THE REGISTRANT. Any hunter who fails the polygraph test will be permanently disqualified from this hunt and all future Coyote hunts.
  11. Any violation of the Pennsylvania Game Laws and rules of this hunt will result in that person or group being disqualified from the hunt.
  12. Official weighs-ins will be done at the designated building on Buck Hill Firearms LLC property from 4:00 PM - 8:00 PM., Friday and Saturday, February 26 & 27 and from 9:00 AM to 4:00 PM on Sunday, February 28, 2016. MUST HAVE IN YOUR POSSESSION AT WEIGH-IN. STAMPED COYOTE CARD, PHOTO ID, AND PA HUNTING LICENSE OR YOU WILL BE DISQUALIFIED. NO EXCEPTIONS
  13. The DEADLINE FOR WEIGH-INS IS 4PM ON SUNDAY FEBRUARY 28, 2016.
  14. Each hunter is responsible for the disposal of his/her coyote carcass. Any coyote(s) left on shop's premises will be subject to a \$60.00 disposal fee per coyote. The fee will be deducted from said person's prize money.
  15. The Prize Money (excluding registration fees for female coyotes) will be awarded AS TOP PRIZE MONEY and awarded for the top three coyotes in weight, to be divided as follows:
    - 1st Prize - 50% of the total Top Prize Money
    - 2nd Prize - 30% of the total Top Prize Money
    - 3rd Prize - 20% of the total Top Prize Money
- Prize for the heaviest female coyote is 100% of the total registration fees paid to participate in the female contest.
16. All prize money will be awarded after official results have been determined. Prize money will be awarded by check upon verification of the contestant's entitlement and in exchange for an IRS Form W-9 signed and completed by each award winner.  
COYOTE REGISTRATIONS WILL ONLY BE ON THE SPECIFIED DATES ABOVE.  
ABSOLUTELY NO REGISTRATIONS WILL BE TAKEN AFTER THE BEGINNING OF THE HUNT
